ELECTRIFYING TRANSPORTATION AND INFRASTRUCTURE

The electrifying transportation and infrastructure workshop will examine trends in the electric vehicle market and the impacts of increasing electrification on electric utilities. The workshop will consider potential policy adjustments that may be necessary to address the authority of utility regulatory bodies as well as policy levers to facilitate the electrification of the transportation sector. There will be opportunities to explore policy that can support consumer uptake, fleet transition, electric buses, and freight electrification.

ENERGY STORAGE

The energy storage workshop will focus on policies to promote greater market penetration of energy storage technologies and will provide an overview of the various value streams that should be considered when developing energy storage policies. The workshop will also include a discussion of costs and benefits to the energy system and market drivers for utility-scale and customer-sited energy storage.

GRID MODERNIZATION

Nearly all aspects of modern life rely on the effective management of data, and the energy sector is no different. The workshop will also look at the policy objectives of a modern grid and ways in which legislatures can develop policies to ensure a grid capable of advanced energy data management.
